SUBLEASE AGREEMENT

Terms of agreement	The rent and any related payments must be paid monthly, on the first day of each month for that particular month, no later than on the 5th day. We recommend that the subtenant pays the rent to the main tenant, who pays the rent to the Student Housing Foundation of Northern Finland (PSOAS). The same terms of agreement set by PSOAS apply to both the main tenancy and sublease agreements. The main tenant is responsible for the fact that there is a valid electricity agreement in the apartment. The subtenant is contractually bound to the main tenant, not to PSOAS. The subtenant is not an internal applicant.		
Other terms of agreement	Tenant can rent their apartment intermediately to another student for a maximum of a one-year period. Subletting is not allowed without a valid reason such as exchange studies, military service or summer vacation. Apartment cannot be sublet if the main tenant no longer needs it. If the main tenant is no longer a student or has moved to another apartment permanently, the tenancy agreement must be cancelled. When the tenancy agreement ends, the apartment is rented out according to the queues. Subtenant does not have a right to stay in the apartment. A breach of terms of agreement leads into cancellation of tenancy agreement.
